Wallkill Group of Vernon, NJ is the lowest qualified bidder. A review of this bid found all material documents were submitted as required. *Settembrino Architects would therefore recommend an award to Wallkill Group in the bid amount of \$548,000 (Base Bid) which is less than the \$550,000 budget estimate, contingent upon availability of funds and counsel review.* It is important to note one (1) unallocated allowance of \$25,000 has been included in the base bid and will be returned to the BOE as a Deduct Change Order if unused at the end of the project.
